COUNCIL NOTES

The May Council Meeting will be postponed until Tuesday, May 22/12 @ 7:00 PM. Council has approved the 2012 Capital & Operating budgets, as well as the tax rates for 2012. Assessment & Tax notices should be mailed by the end of May.

Meeting Schedule: Regular Council meetings are the 1st Monday of the month & Workshop Meetings are the 3rd Monday of the month. If Monday is a holiday, the meeting will be held on Tuesday. Meetings start at 7:00 pm in the Village office.

Census: The Village will be conducting a census the later part of May. May 14th is the official census date. The Federal census showed a reduction in population for the Village of 42 residents which has a significant impact (reduction) on grant funding for the Village. Please cooperate with our census takers when they visit your home. We are only interested in the number of residents, students included, as of May 14th, 2012.

Changes to this schedule are posted at the office & in the post office.

The **Village Campground** will re-open for the May long weekend. Contact the Village office for information & reservations. The sewage dump is available for use.

If you wish to address Council as a delegation, contact the office by Thursday morning the week prior to the meeting. Council meetings are open to the public. Council provides time for a Q&A at the end of the meeting.

Recycling: The Village has received several complaints about garbage being left in and around the recycle building. The recycle building is for specified recyclable items **ONLY**. See reverse side for details. Newell Recycling has the option of removing the building from the Village if the misuse continues.

- Please keep all shredded paper in plastic bags as it is very messy! Please no newsprint.
 - Color and white paper with envelopes, office & house hold paper.

- NEWSPRINT:**
- What comes in newsprint goes with newsprint.
 - Phone books
 - Flyers
 - Magazines

- TIN CANS:**
- Clean and labels off
